- (1) In the first paragraph, the words "along with liabilities" shall be deemed always to have been inserted at the end;
- (2) Immediately after the first paragraph and before the words "This is subject to the following" the following explanation shall be deemed always to have been inserted, namely.,

**"Explanation:-**

It is hereby declared that the Assets and Liabilities referred to in this paragraph shall be deemed to include all the claims, demands, liabilities, decrees, pending legal proceedings, against the Government in respect of the Assets and Liabilities which are transferred to the Cauvery Neeravari Nigam Limited";

- (3) for the conditions (a) and (b) in the second paragraph, the following shall be substituted, namely,-

"The Committee to be set up under the chairmanship of Additional Chief Secretary to Government of Karnataka, as envisaged in the Government Order vide reference (1) will finalize the inventory and the value of the Assets and Liabilities excluding those referred to in the above explanation".
